### INVESTMENT OBJECTIVE

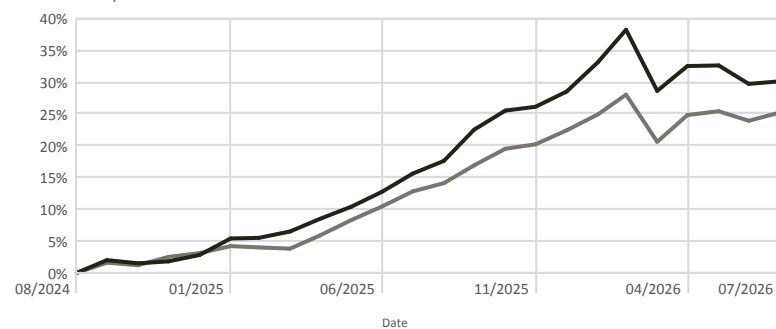
The All Weather FR Balanced Fund is a managed portfolio with the objective of providing investors with a moderate to high long term total return.

### INVESTMENT POLICY

In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. Portfolios may include foreign schemes only if their regulatory environment provides investor protection that the manager and trustee judge to be at least equal to South Africa's standards. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act.

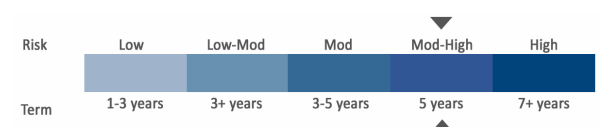

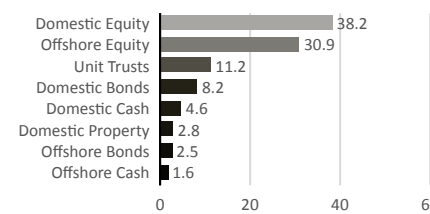
### Moderate - High Risk
